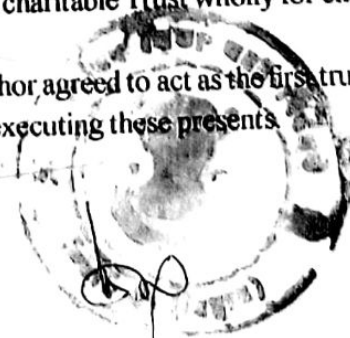

5. BOARD OF TRUSTEES:

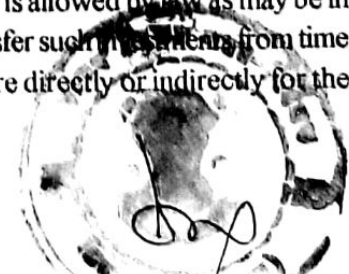

b) The Trustees shall invest the properties and moneys of the Trust in such manner as prescribed under section 11 of the Income Tax Act, 1961 and other statutory laws.

c) The Trustees may borrow if need be, against security of the assets of the Trust by way of bank overdrafts, loans or otherwise as may be necessary, for the benefit of the Trust and for more effectively carrying out the objects of the Trust, provided however the trustees unanimously agrees in advance on such borrowing and limited to the terms of their decision or agreement and may authorize two or more of the Trustees to execute such documents deeds paper, etc. as may be necessary in connection therewith.

d) The Trustees may authorize an one or more Trustees to hold any property or any fund or any investments of the Trust subject however to the terms of these presents in such manner and subject to such terms and conditions, rules and regulations as the Board of Trustees may, from time to time think fit and proper to adopt.

e) If need arises, the Trustees may invest the Trust Estate either in the purchase of immovable properties or of mortgage immovable properties, or in such manner is allowed by law as may be in forced from time to time and to convert, alter, vary, dispose of or transfer such investments from time to time, provided that such investments shall not be made which are directly or indirectly for the

benefit of any person referred to in Sub- Section 3 of Section 13 of the Income Tax Act, 1961, or any subsequent amendments as may be made from time to time.

f) Keeping in view the objects of the Trust, the Trustees shall be at liberty to sell such portions of movable or immovable properties forming part of the Trust Estate either by public auction or by public contract at such price or prices and on such terms and conditions relating to title or otherwise in all respects as they may in their absolute discretion think fit and to rescind or vary any contract for the sale there of and to resell the same, without being answerable for any loss occasioned thereby and to execute all conveyances or other assurances and to pass valid and effectual receipts and discharges for all money received by them.

g) The Trustees may manage or supervise the management of lands, heriditaments, and premises for the e time being compromised in the Trust Estate or any part thereof with power to erect, pull, down, rebuild, add to alter and repair houses and other buildings and to keep the same insured against loss or damage by fire and / pr other risks for the benefit of the Trust.

h) If need arises, the Trustees may devide the immovable property or properties from time to time belonging to the trust either from year to year or for any fixed term or for any terms of years or on monthly tenancies at such rent and subject to such convenience and conditions as they may think proper and also accept surrenders of lease and tenancies and generally manage the same in such manner as they think fit.

i) The Board or Trustees shall meet at least twice in a year and their proceedings shall be recorded regularly in a minute book to be maintained for the purpose. In any resolution to be passed touching the administration of the trust, the opinion of the majority shall prevail. It shall be competent, however for the trustees to decide matters by circulation. In case of there being equality of votes, the President of the meetings of deciding the issue.

j) A resolution in writing circulated amongst all the Trustees and signed by a majority of the Trustees shall be valid and effectual as if it had been passed at a meeting of the Trustees duly called and convened.

k) The Trustees may open and operate account (s) with any scheduled bank or banks or regional rural bank and the accounts will be operated jointly by any two among the Managing Trustee/ President, Secretary and Treasurer.

l) The Board may by resolution extend the activities of the Trust or undertake any activity in furtherance of the main objects of the Trust, and /or amends the same from time to time.

m) Proper Books of accounts shall be maintained in the name of the Trust and shall be audited by a Chartered Accountant. The Trustees shall cause true and accurate accounts to be kept of all money received and spent and of all matter in respect thereof in course of management of Trust properties of in relation to the carrying out of the objects and purpose of the Trust as well as of the assets, credits and effects of the Trust properties.

n) To do such other lawful things as are incidentals in carrying out the administration and management of the Trust.

o) The Trustees may frame rules and regulations as to the duties and responsibilities of each Trustees, to appoint sub committees, and to determine mode of conducting any other matters connected with the administration/furtherance of the objects of the Trust.

p) The Trustees shall from time to time after meeting the expenses and incidental to the management of the Trust properties and of the Trust decide the particular object of objects for which the income or corpus of the Trust Fund or properties for the time being available shall be applied.

q) If the income from the Trust property in a particular year is not fully telexed the unexpended income subject to the applicable provisions of the Income Tax Act, 1961, shall be carried over to the next year or years and spent in such subsequent year or years for the advancement of any of the objects of the Trust.

r) The Trustees may reimburse themselves and pay and discharge out of the Trust fund all expenses incurred by them in or about the execution of the Trust or any of their duties under these presents including traveling expenses, but will not be entitled to any remuneration.

t) The Trustees may appoint Managers, Lawyers, Auditors, Architects and other technical staffs for the furtherance of the objects of the Trust.

u) The Trustees shall have full power to compromise or compound all actions, suits and other proceedings and settle differences and disputes touching the Trust Estate and/or the Trust properties and to do all other acts and things fully and effectual without being liable or answerable for any bonfire loss occasioned thereby.

v) No Trustee shall be liable for any loss not attributable to his own dishonesty or of omission by him of an act amounting to breach of Trust.

7. CUSTODY OF DOCUMENTS:

The managing Trustee or his nominee or any other Trustee if so authorized by the Board of Trustees shall have the custody of all the documents, deeds of title relating to the Trust priorities and investment and the books of account and other records relating to the Trust and shall be responsible for the preservation of the same.

8. FINANCIAL YEAR:

The financial year of the Trust will commence on 1st April and will end on 31 March of the next year.

9. IRREVOCABILITY:

It is declared that the Trust is irrevocable. If the Trust fails for any reason, in the opinion of the Trustees, the net assets of the Trust both movable and immovable shall be
